- A. KEN NASTROM CAME BEFORE THE BOARD TO CLARIFY THE POSSIBILITY OF USING A PLASTIC CULVERT IN ONE OF HIS DEVELOPMENTS. AFTER SOME DISCUSSION, IT WAS NOTED THAT THE CAMBRIDGE TOWNSHIP ROAD ORDINANCE 101 DOES SPECIFY THAT CULVERTS NEED TO BE **STEEL** WITH APRONS (SECTION 10 #6). ALSO, THE TOWNSHIP'S DRIVEWAY PERMIT SPECIFIES THAT THE CULVERT BE GALVANIZED METAL (NO PLASTIC) WITH APRONS. THE USE OF PLASTIC DOES MAKE THE CULVERT SUSCEPTIBLE TO FIRE DAMAGE (eg. GRASS FIRE). USING THE TOWNSHIP'S ROAD ORDINANCE 101 AS THE DECISION FACTOR, THE BOARD ENDORSES THE ORDINANCES STATEMENT THAT THE CULVERT NOT BE PLASTIC.

- v) NORTH PINE LAKE ROAD THE TOWNSHIP DID SOME CULVERT WORK ALONG WITH FISH LAKE TOWNSHIP IN THE AREA.
