 attorney (lacking a legal description of the property to be purchased). The attorney
 is waiting for Kyle Roddy, the surveyor, to get a legal description of the tract to be
 split off.

8. ROAD BUSINESS

- A. ROB'S REPORT:
 - i) 2017 Ford F-450 windshield replacement the township has received reimbursement for the cost from MATIT Insurance (\$822.94).
 - ii) **Snowplowing** He reports a minimum of snowplowing and mainly salting intersections.
 - iii) Brush mowing has been completed.
 - iv) Fish Lake Township / North Pine Lake Road Project Rob notified the Board that Fish Lake Township is looking into getting a bond to reconstruct and pave North Pine Lake Road in 2026. Cambridge Township has about 1400' of North Pine Lake Road that is in the Township. The estimate for Cambridge Township's share would be approximately \$80-90,000.

No action was taken at this time.

- v) Road Salt Status Rob has been in contact with the road salt vendor and the township is required per contract to purchase another 31 tons of road salt. The vendor has waived that amount if the township would take a complete load of 28 tons. The township does have accessory storage if needed for the extra load of road salt.
- vi) Fjeldheim Road North of Co. Rd 6 trees have grown and are hanging over the road on a 250-300' section of Fjeldheim Road. Rob received a number of quotes to remove the trees, brush and grind stumps. The following quotes were received:

1) Haven Stump Removal, Inc \$5,000
2) Tom Lundeen (no stump grinding) \$5,500
Rob was notified that the Board did accept Haven Stump Removal's quote of \$5,000 to do the project.

vii) 357th AVE – going West from State Hwy 65 there is an area of about 1300' of lowland and the paved road is getting rutty. Rob received the following quotes for the Board to consider:
