**NOTICE OF FILING FOR THE 2026 STATE GENERAL ELECTION  
ISANTI COUNTY, MINNESOTA**

The following is a notice of federal, state, and county offices that will be voted for at the state general election to be held on Tuesday, November 3, 2026. The filing period for these offices begins at 8:00 a.m., Tuesday, May 19, 2026, and ends at 5:00 p.m., Tuesday, June 2, 2026.

Note: Filing offices will be closed Monday, May 25, 2026, in observance of Memorial Day.

The place of filing for federal offices is the Office of the Secretary of State, Veterans Services Building, 20 West 12<sup>th</sup> Street, St. Paul, MN 55155-1299.

The place of filing for state offices is with the Office of the Secretary of State or with the county auditor of the county in which the candidate resides.

The place of filing for county offices is the Isanti County Auditor-Treasurer's office, 555 18<sup>th</sup> Avenue SW, Cambridge, MN 55008.

Candidates may file in person or by mail if the filing is received during the filing period. Candidates who will be absent from the state during the filing period and meet the requirements of Minnesota Statutes section 204B.09, subdivision 1a, may arrange to file during the seven days immediately preceding the candidate's absence from the state.
